Jennifer Schmitt, President, called a meeting to order at 6:30 pm. Pledge of Allegiance recited. Review of previous minutes (February 10, 2026) John Turnbull motioned for approval, Scott Price seconded motion. Minutes approved.

**President's Report** given by Jennifer Schmitt.

- **Community Concern:** A few individuals have brought up concerns about fire season and the fireworks. Drone show was suggested but the cost begins at 25K which is not within our budget. Chamber feeling is that without the professional fireworks show there would be more at home firework displays which pose a much greater concern for fires. Chamber will consider purchasing a few reusable signs that will encourage people not to set off their own fireworks.
- **City of Crouch Collaboration:** At the last City Council meeting it was evident that collaboration between the chamber and city is not going to be feasible. The City will provide on their own porta potties and trash dumpsters within city limits but will not coordinate with the chamber.
- **Fourth of July:** We spoke with Adam Noakes who will provide the same show as last year with potential tweaks to the show for a different experience. \$20,000 with 25% off if paid by end of April would be \$15,000 so we should be able to pay that when the chamber sponsor renewals come in the beginning of April. Adam will attend the next meeting to provide an update. Chamber will hold a day-of raffle for someone to "Push the firework start button" for the show. Raffle tickets will be sold on the 4th to recoup some of the firework money. The Mud Room will be responsible for catching the ducks during the Duck Races again.
- **Chamber Scholarships:** Should the chamber continue to provide scholarships to GV High School students when these students do not give back into the community? Debate for and against took place. Scott Price motioned that the chamber will "provide a \$500 scholarship to one GVSD senior with the stipulation that they will volunteer a minimum of 5 hours at a chamber approved community event. Volunteer hours must be approved by the chamber and 5 hours must be completed before the scholarship will be paid". 4 Yays 4 Nays - Jennifer Schmitt breaks tie with a yay vote. Motion passes.

**Vice-President's Report** given by Scott Price.

- **Soap Box Derby** - We need someone that is willing to run this event from 11:00am - 2:00 pm. Last year there were several crashes so the cars need to be repaired. Samantha motions "all soap box derby cars are the responsibility of the owner of the car and must be in proper working order prior to the Fourth. No car that is unsafe can be used on the Fourth" Scott Price seconded motion. Email to be sent to car owners sharing information. Kraig Wees suggested that Steve Semmel could possibly arrange for the sand to be dropped again.

**Secretary's Report** given by Samantha Turnbull.

- **SWITA Update:** The 2026-2027 Grant Application was submitted and we will find out the grant amount in May.
  - SWITA will only reimburse for advertising campaigns focused on multi-day stays in a region. Fourth of July remains safe as we have a late night event which encourages overnight stays.
  - SWITA will not reimburse for Chamber hosted events (except the Fourth). Chamber funds can only be used in the support of advertising events that promote a multi-day stay. If a business decides to host the Spring or Fall Festival then they can request advertising funds from the chamber and the chamber can promote the event.
  - SWITA grant requirements are ever evolving and the chamber is lucky to be grandfathered in as SWITA usually does not allow for those under two hours from a major city to qualify for the grants.
  - SWITA will also continue to fund influencers, billboards, road signs, and radio/media ads as long as approved by the SWITA prior to production.
  - SWITA funds cannot be used to promote a single business or event, instead must be tourism focused with multi-day stay as the goal.
- **GV Coupon book:** arrives on Wednesday will be distributed on Friday.
